

## **ARIZONA VOTERS' BILL OF RIGHTS**

YOU HAVE THE RIGHT TO VOTE – it's the law, and you have the proof in your hands! You'll notice letters and numbers after each of your rights listed below; those codes tell lawyers and poll-workers where to find the actual Arizona statute that protects your right to vote. These rights are guaranteed to properly registered and qualified voters. You have the right to take this Bill of Rights into the voting booth with you. If you feel your rights have been violated, please find an Election Protection volunteer to assist you or call toll free: **1-866-OUR-VOTE** (1-866-687-8683).

## YOU HAVE THE RIGHT TO VOTE:

- 1. IF YOU ARE IN LINE at the polling place when the polls open at 6:00 a.m. or close at 7:00 p.m. A.R.S. § 16-565(A) and (D).
- 2. BY REGULAR BALLOT if you show ID that contains your name and current address. YOU SHOULD BRING TO THE POLLING PLACE PHOTO ID (such as a valid, current Arizona driver's license or non-operator ID, Tribal ID, or other government-issued ID that contains your photograph). If you do not have valid Photo ID, you must bring two forms of non-photo ID that contain your name and current address (such as utility bills, bank statements or vehicle registration card). Call 1-866-OUR-VOTE if you have any questions about what ID you must bring. A.R.S. § 16-579(A).
- 3. BY PROVISIONAL BALLOT if the name and address on your ID does not match the name and address on the polling place signature roster.
- 4. BY CONDITIONAL PROVISIONAL BALLOT if you do not have one form of Photo ID, or two forms of non-photo ID. Please call 1-866-OUR-VOTE for further information about how to ensure that your ballot is counted if you must vote a Conditional Provisional Ballot.
- 5. BY PROVISIONAL BALLOT if your name is not on the precinct register, but you present proper identification showing name and address. A.R.S. § 16-584(B).
- 6. BY PROVISIONAL BALLOT IF YOU HAVE CHANGED YOUR NAME without re-registering, if you provide identification with your new name. A.R.S. § 16-137.
- 7. With assistance from anyone you choose or from two election officials (one of each major political party). A.R.S. § 16-580(G).
- 8. Using an alternative voting procedure if you are elderly or handicapped and the polling place is not accessible to you. A.R.S. § 16-581(A).
- IN YOUR NEW PRECINCT by provisional ballot if you have moved within the same county in Arizona without re-registering but you provide identification with your name and new address. A.R.S. § 16-135(B).
- 10. IN YOUR OLD PRECINCT if you have moved to a new county in Arizona within 29 days of election day. A.R.S. § 16-125.
- 11. BY REGULAR OR PROVISIONAL BALLOT EVEN IF SOMEONE CHALLENGES your right to vote. A.R.S. § 16-592(B) and (C).

- 12. WITHOUT SIGNING YOUR NAME if you are unable to sign due to a physical disability. A.R.S. § 16-579(D).
- 13. If you have Only ever been convicted of one felony, if you have fully completed your sentence (including any period of probation or parole), and have re-registered to vote. A.R.S. § 13-912(A); A.R.S. § 16-165(A)(4) (Registration cancelled upon felony conviction).
- 14. With a paper ballot if the voting machines break down and cannot be repaired or replaced. A.R.S. § 16-574(B).
- 15. With a replacement ballot if you make a mistake or "spoil" your ballot or ballot card. A.R.S. § 16-585
- 16. During your regular work hours without penalty if your regular shift starts before 9:00 a.m. and ends after 4:00 p.m., although your employer has the right to set the time during the day you can take off to vote. A.R.S. § 16-402(A).
- 17. Without anyone trying to influence your vote when you are within 75 feet of a polling place. A.R.S. § 16-1018.
- 18. TO VOTE AND RECEIVE BALLOT INSTRUCTIONS In Spanish in Cochise, Greenlee, Maricopa, Pima, Santa Cruz, and Yuma counties; in Apache in Apache, Gila, Graham, Navajo, and Pinal counties; in Navajo in Apache, Coconino, and Navajo counties; in Pueblo in Apache, Coconino, and Navajo counties; in Tohono O'Odham in Maricopa, Pima, and Pinal counties; in Yaqui in Pima county; and in Yuman in Yuma county. 42 U.S.C. § 1973, et seq.; 67 Fed. Reg. 144, pp. 48,871-48,877 (2002).
- 19. TO RECEIVE A DEMONSTRATION on using the voting equipment before casting your vote. A.R.S. § 16-578(A) and (B).
