I received your informal complaint dated 12/18/2017 in regards to your claim that : "The State of Arizona failed to take advantage of the procedural steps to appeal the "illegally/enient sentence" and therefore has "waived the error". A.R.S 13-4032(6).

I reviewed your sentencing documents and it states: "Natural life without possibility of parole for 25 years".

A review of policy indicates :

D. O 802

1.2 The following are not grievable under the Inmate Grievance Procedure:

- 1.2.1 Actions of the Governor or State Legislature.
- 1.2.2 Decisions of the Arizona Board of Executive Clemency.
- 1.2.3 Judicial proceedings or decisions of the Courts.

Additionally, a time computation has been provided as of 12/21/2017 as requested.

AIMS was reviewed and it was determined that your sentence documents correctly reflect as such in our systems.

This issue is not resolved as this is not a grievable issue per D.O 802. Your release information was last updated on 1/05/2017. If you have any time computation issues, you can submit an inmate letter to Central Office requesting a file audit. If you are not satisfied with this response you may file a Formal Complaint on 802-3 within policy time frames.
