Dear Public Records Manager:

Pursuant to Arizona's public records law, A.R.S. § 39-121 *et seq.*, the ACLU of Arizona hereby requests the right to examine and copy or to be furnished with copies of public records in the possession of the office of the Arizona Secretary of State. These records are not sought for any commercial purpose. Nevertheless, we agree to reimburse you for reasonable costs associated with producing the requested records. If the costs will exceed \$50, please let us know before you incur the costs. When possible, we prefer to receive information in electronic format, especially if electronic copies will lower the cost of production. If your agency or department does not maintain the records below, please advise who does and include the proper custodian's name and address when possible.

If the request is denied in whole or in part, please justify any redactions or withholdings by referencing the specific grounds on which the information is withheld under the Public Records Law. All divisible portions of otherwise exempt material must be produced. We reserve the right to appeal your decision to withhold any information.

We seek the following records in the possession of the state of Arizona:

1. All records provided to the Presidential Advisory Commission on Election Integrity ("Commission") in response to Vice Chair Kris W. Kobach's June 28, 2017 letter soliciting "your views and recommendations," including all responses to the seven questions posed in the June 28, 2017 letter, and any supporting records provided;
2. All records containing, referring to, supporting, or related to your "views and recommendations" to the Commission;

Christian Adams, Ken Blackwell, Luis E. Borunda, Matthew Dunlap, Bill Gardner, Kris Kobach, Alan Lamar King, Connie Lawson, Christy McCormick, Vice President Mike Pence, and Hans von Spakovsky.

Please comply with this request on or before July 31, 2017 (*see* A.R.S. §39-121(D)(1) and (E), public records must be furnished “promptly”).
